Re: CWSAA Competitor Pass Release Agreement – must be completed by August 11, 2023

Dear Competitor Pass Applicants,

We have commenced the process for allocating Competitor Passes for the 2023-24 Season. The process is slightly different this year, with an important deadline on August 11, 2023. We have a limited number of passes and anticipate that, unfortunately, not all applicants will be allocated a pass this year. Therefore, it is very important that you review this communication, and read and complete your Release Agreement by August 11, 2023.

Release Agreement

The allocation and issuance of the Competitor Pass is subject to, among other qualifications, the applicant, and their parent/guardian in the event of a minor, signing a Release of Liability, Waiver of Claims, Assumption of Risk Agreement (the "Release Agreement").

New timing this year (time sensitive deadline)

To be considered in the initial round for a Competitor Pass for the 2023-24 Season - the Release Agreement must be completed by August 11, 2023. If your Release Agreement is not completed by August 11, 2023, your application for a Competitor Pass will not be considered in the initial round of allocating available Competitor Passes. If all Competitor Passes are allocated in the Initial Round — applicants without a completed Release Agreement will not have an opportunity for consideration. If you want to be considered for a Competitor Pass for the 2023-24 Season — you must ensure you read and complete your Release Agreement by August 11, 2023.

Please note that in addition, the issuance of a ticket/pass by a particular ski area operator may be subject to the completion of that ski area operator's Release of Liability, Waiver of Claims, and Assumption of Risks and Indemnity Agreement. The ski area operator may refuse to issue a pass/ticket if the ski area operator's Release Agreement is not completed. Ski area operator Release Agreements can be found at the ski area operator's website or by contacting their guest services department.

Where to Complete your Release Agreement:

CWSAA is excited to be partnering with 1Risk again on the digital Release Agreement for the upcoming 2023-24 season.

As there are different ages of majority in different provinces/territories, there are 4 different versions of the electronic waiver. *Please refer to the table below by passholder age and province/territory of residency to find the link to the appropriate waiver. Completing the wrong version may impact the allocation or issuance of a Competitor Pass. It is your responsibility to ensure you complete the correct version of the Release Agreement.*
